A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MASON TO AMEND THE NOTICE OF ELECTION FOR THE GENERAL ELECTION OF MAY 6, 2017, TO SET THE ELECTION DAY POLLING PLACE AT 1024 MCKINLEY AVE, THE RICHARD ECKERT CIVIC CENTER.

WHEREAS, the General Election scheduled for May 6, 2017 will include the voting for two places on the City Commission and concurrently include the voting for two at-large places on the Mason ISO Board of Trustees,

WHEREAS, there is an expectation of a large number of citizens voting on that day for the contested races,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MASON, TEXAS:

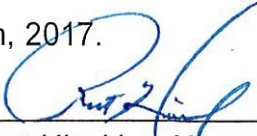
1. The Notice of General Election shall be amended to state:

"Notice is hereby given that the polling place for the Election Day voting shall be open from 7:00 a.m. to 7:00p.m. on May 6, 2017 for voting in a general election to elect City Commissioners: District 2 and District 4. Voting by personal appearance will be conducted at 1024 McKinley Ave. known as the Richard P. Eckert Civic Center."

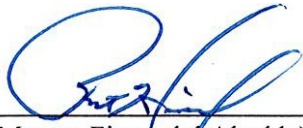
